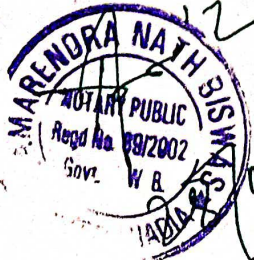

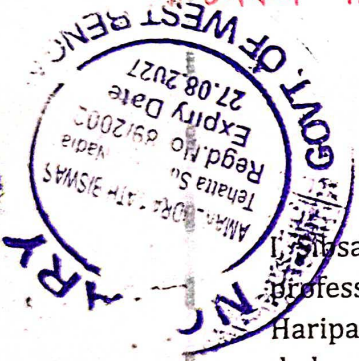
AFFIDAVIT

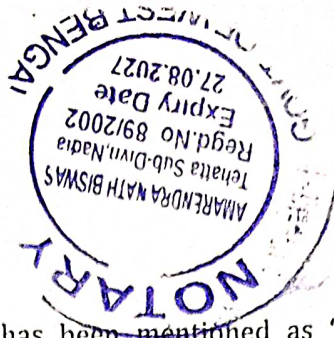

1. That I am Indian Citizen.
2. That I am the Officer-in-Charge of "Government General Degree College, Tehatta" situated at Tehatta, Dist.- Nadia, PIN- 741160.
3. That our college was established vide Notification No. 185-Edn (A)/10M-11/13 dt.- 28.02.2014 issued by Appointment Branch of Higher Education Department stating that "The Governor is pleased to accord approval towards the establishment of a Government General Degree College at JL. No.-101, Mouza- Tehatta, P.S.-Tehatta in the district of Nadia." However, up to the best of our knowledge, any order naming our college was never issued by the Higher Education Department.
4. That the University of Kalyani in its Temporary affiliation letter bearing No. RPS/Att. Coll./71/347/2015 S-17 dt.- 21.05.2015, has mentioned our college just as Government General Degree College along with Tehatta, Dist.-Nadia as address.

That our college name has been mentioned as "Government General Degree College, Tehatta" in the Certificate of AISHE bearing Reference No. C-53097-2021 issued by Ministry of Education Department of Higher Education Statistics Division, New Delhi, Government of India. However, in the HRMS portal, the college is registered as Govt. General Degree College, Tehatta. Whereas, in the online SAR of employees, beside this, the name Govt. General Degree College at Tehatta is also used.
 6. On the other hand, Banglar Uchchashiksha portal carries our college name as Tehatta Government College. The web-address of our college is <http://tehattagovtcollege.ac.in> and the email Id used for official communication is tehattagovtcollege@gmail.com both of which are related to the name Tehatta Government College. Student's Registration Certificate & Admit Card issued by the University of Kalyani also bears the same name for college. Alumni Association of our college (bearing No. S0039417 of 2023-2024) has also been registered under this name.
 7. Besides this, the above mentioned college names are used interchangeably in Appointment Letters and Transfer Orders of employees, different College Notices, college Letter heads, different posters, flex, college hoardings, feedback forms, academic seminars, workshops and cultural programmes, extra-curricular activities, Add on Courses, Certificates issued by our college, various official documents prepared for NAAC purpose and multiple official stamps.
 8. That said "Government General Degree College, Tehatta", "Tehatta Government College", "Govt. Gen. Degree College, Tehatta", "Govt. Gen. Degree College at Tehatta", "Government General Degree College at Tehatta", "Govt. General Degree College at Tehatta" and "Tehatta Govt. College" are same and represent this college, "Government General Degree College, Tehatta".
 9. That from now on, we want to use our college name as "Government General Degree College, Tehatta" in every document & everywhere and also use official stamp as "Govt. Gen. Degree College, Tehatta."
 10. That this affidavit is required for official purpose.

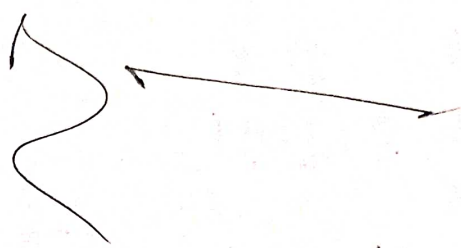
